Chapter Service Scholarship Award

(As approved by Board vote 9/14/10)

- Purpose:** To promote IREM Education and Chapter Service to new and developing members.
- Eligibility:** Associate, ARM[®] Members, ACoM Members, CPM[®]-Candidate Members and CPM[®] Members who have held the CPM[®] designation for less than one year.
- Honorary:** Past Presidents' Advisory Board (PPAB)
- Amount:** \$500 or amount agreed by vote of the Executive Council.
- Proposal:** On behalf of Chapter 92, the PPAB will select and award this scholarship annually to eligible applicants. To be eligible, applicants will have performed one of the following in the past year: served or chaired a committee(s), participated in IREM 92 service or educational activities (i.e. Meeting Volunteer, Classroom Set-Up, Community Service Event, etc) or performed a regular meeting task such as 50/50 Raffle, Greeting/Welcoming Committee etc
- Other:** The Scholarship may be awarded in whole to a single individual or multiple applicants at the Honoraries' discretion.

Scholarship funds may be used toward any IREM class, seminar or conference at the Chapter, Regional or National level. Award may also be applied toward Chapter and National dues and/or Chapter Meeting fees.

The Scholarship will be funded from Chapter 92's budgeted funds. Awarded funds will remain in the Chapter's account until such time that the recipient registers for the IREM event(s).

This Scholarship will be awarded annually at the November Installation meeting to be used within the following calendar year. At the end of the calendar year, any unused funds will remain in the chapter's account to be available for future scholarship awards.

Application Deadline – October 26, 2026

- Award:** \$500 - To be awarded at the November general membership dinner meeting (11/12/26). Scholarship must be used within the next calendar year and can be applied toward IREM education, seminars, conference, meetings and/or Chapter dues.
- Eligibility:** ARM® Members, ACoM Members, CPM® Candidates and CPM® Members who have held their designation for less than one year.
- Criteria:** On behalf of Chapter 92, the Past Presidents' Advisory Board will select and award this annual scholarship to an eligible applicant. Applicants will be considered based on eligibility and will have performed one of the following in the past year: served or Chaired a Committee(s); participated in IREM 92 Service or Educational Activities (i.e. Meeting Volunteer, Classroom Set-Up, Community Service Event, etc); attended general meetings on a regular basis and/or performed a regular meeting task such as 50/50 Raffle, Greeting/Welcoming Committee etc.
